

- For the project community: EU-FarmBook wants to help to ensure the use & longevity of your practical results





7 years project

In several phases:

Inception phase (Aug. '22 – Jan. '23): 'Getting started' **Phase 1 (Feb. '23 – Feb. '25): Building and engagement** *Step 1: EU-FarmBook digital platform further development (reaching TRL 5-6)*

Step 2: Getting connected & further research in the identification and modelling of more user types

Phase 2 (Mar. '25 – Aug. '27): Uptake and maintenance – with focus on the finalization of the EU-FarmBook platform's technical development (TRL 7-8)

Step 3: Managing and enhancing knowledge supply to the EU-FarmBook

Phase 3 (Sept. '27 – Aug. '29): Outreach & sustainability

Step 4: Promoting use of the EU-FarmBook

Step 5: Feedback and refinement of the EU-FarmBook Platform

EU-FarmBook will produce a facilitation toolkit, providing the Ambassadors with clear tools and guidelines, that enable them to play their role as connectors between the project and external stakeholders.


