# **Executive Summary**

This report presents the deliverable D3.15 of Work Package (WP) 3 of the EU-FarmBook project. The main aim of the WP3 is to embed the EU-FarmBook platform into the contemporary policy context of strengthening Agricultural Knowledge and Innovation Systems (AKISs) by effectively connecting the platform with relevant actors, policies, projects, and other instruments in place at Member State (MS) and EU levels.

The EU-FarmBook consortium has 19 multi-actor partners (i.e. partners with complementary profiles and types of knowledge – scientific, practical and other) nominated as EU-FarmBook Ambassadors (AMB) with geographical and/or sectoral scope and responsibilities. These partners cover the 27 MSs and the agriculture and forestry sectors, work to set up and expand a network of institutional AKIS actors to effectively connect the EU-FarmBook platform with a) the AKISs of each individual MS taking into account their specific characteristics and dynamics, b) selected key 'sectors' of the CAP, including organic farming, forestry, young farmers and farm advisory services and, c) the community of multi-actor projects funded by Horizon 2020 and Horizon Europe, Cluster 6 of Horizon Europe and the CAP-funded EIP-AGRI Operational Groups (OGs).

To achieve the aim stated in WP3, the EU FarmBook AMBs are instrumental as they secure the provision of information about the situation in each MS and Sector and its evolution with time. For this purpose, the AMBs will perform a periodic assessment with focus on the state-of-play of the embedding of results from EU-funded research and innovation (R&I) projects into the national/regional AKISs with specific reference to the planning, development, and management of 'knowledge reservoirs (KRs) for practice'. These periodic assessments will provide the project with a complete overview of the situation in each MS and Sector, key information to pinpoint opportunities to connect existing or new knowledge platforms with the EU-FarmBook and to embed the use of the EU-FarmBook platform within EU/national/regional AKISs. Moreover, these assessments will provide the AMBs with the necessary understanding of how and where the EU-FarmBook fits in the MSs and Sector AKISs and with the needed information to revise, adapt and update their stakeholder engagement plan.

The title of D3.15 was changed from "Set of periodic assessment policy notes (1)" to "First periodic assessment note" as this first deliverable provides preliminary insights into the situation of the MSs regarding the development of knowledge reservoirs and the structure and content of the first periodic assessment. As the project progresses and the situation in the MSs and the Sectors evolve, the content of the periodic assessments will be adapted accordingly.



## 1. Introduction

Work package 3 has an important role in the project connecting the creation of the EU-FarmBook platform in WPs 1 & 2 and the dissemination and exploitation activities of WPs 4 & 5. WP3 aims to embed the EU-FarmBook platform into the contemporary policy context of strengthening Agricultural Knowledge and Innovation Systems (AKISs) by effectively connecting the platform with relevant actors, policies, projects, and other instruments and to respond to the changing characteristics of the evolving post-2020 AKIS 'ecosystems' at EU and Member State (MS) level. The EU-FarmBook consortium includes 19 multi-actor partners (i.e. partners with complementary profiles and types of knowledge – scientific, practical and other) nominated as EU-FarmBook Ambassadors (AMBs) with geographical and/or sectoral scope and responsibility. These partners cover all 27 MSs and work via the tasks in WP 3 to set up and expand a network of institutional AKIS actors. The AMBs have the role of connecting the EU-FarmBook platform with a) the AKISs of all individual MSs by their specific characteristics and dynamics, b) selected key 'sectors' of the CAP, including organic farming, forestry, young farmers and farm advisory services, and c) the community of multi-actor projects funded by H2020, Cluster 6 of Horizon Europe and the CAP-funded EIP-AGRI Operational Groups (OGs).

WP3 has adopted an agile approach to the planning and coordination of the AMBs network activities in response to the 'evolving AKIS ecosystem' as the MSs progress with their implementation of the AKIS Strategic Approach of the CAP Strategic Plans and with the ongoing implementation of Cluster 6 of HEU. WP3 has five tasks:

- Task 3.1: Adaptative planning and coordination of knowledge networking activities.
- Task 3.2: Developing the skills and capacities of EU-FarmBook ambassadors.
- Task 3.3: Understanding and evaluating the state and evolution of the AKIS 'ecosystem' knowledge reservoires at national and EU level.
- Task 3.4: Promote and facilitate the uploading of knowledge objects.
- Task 3.5: Feedback loops for evaluation and learning.




Fig. 1: EU-FarmBook AMB adaptative planning process

Work Package 3 (Task 3.1) planning will remain flexible and adaptive throughout the project with an iterative approach applied to develop 'tailor-made' responses by the AMB for each MS/sector according to the specific characteristics of their national AKIS and the progress made with their AKIS co-ordination bodies, the innovation strand of their CAP Networks and the rolling-out of EIP-AGRI interventions. The number of iterations of network activities will vary depending on the MS and Sector and will be based on a periodic assessment conducted by AMBs (Task 3.3). An overview of the AMBs adaptive planning process and the relationships with T3.2 and T3.3 is provided in Fig. 1. Furthermore, the AMBs will play an active role in promoting and supporting the uploading of knowledge objects from EU-funded projects at MS and EU level (Task 3.4) and in providing feedback to improve the EU-FarmBook platform and ensure it meets the expectations/needs of users and other AKIS actors (Task 3.5).

The EU-FarmBook AMBs are actively supported to conduct these tasks in WP 3 (as well as tasks in WP 4 and WP 5) through WP3 Task 3.1, Task 3.2 and Task 3.3. WP 3 Task 3.1 supports the AMBs to develop their tailor-made engagement/network strategies



through facilitating an adaptive planning process. WP3 Task 3.2 provides the necessary development of their skills and capacities to perform as a community of EU-FarmBook AMBs at national and EU sectoral level. WP3 Task 3.3. provides the necessary guiding questions and tools to perform a periodic assessment (every 12 months, M9-M69). With the periodic assessment the AMB will be able to assess the state-of-play with the embedding of results from EU-funded research and innovation (R&I) projects into the national/regional AKISs with specific reference to the planning, development, and management of 'knowledge reservoirs for practice'.

The aim of this deliverable D3.15, the first deliverable of T3.3, is to provide an overview of the state of play in the planning and implementation of online knowledge reservoirs for exchange of agricultural and forestry practices at MS level and to present the structure and the questions of the first periodic assessment. This deliverable summarizes the information gathered on the status of national/regional knowledge reservoirs in the Member States (chapter 2). This data is key for the MS AMBs, as it represents the starting point for the identification and creation of opportunities to collaborate and to connect the EU-FarmBook with MSs' initiatives. Moreover, this deliverable also presents the structure and questions of the first periodic assessment. The assesment is a tool developed to evaluate the state-of-play with the embedding of results from EU-funded research and innovation (R&I) projects into the national/regional AKISs with a special focus on the planning, development, and management of 'knowledge reservoirs for practice' (chapter 3). Finally, in chapter 4, the next steps for the periodic assessment are presented as the periodic assessment will be a recurrent activity part of the AMB adaptive planning process.



# 2. Overview of the status of the knowledge reservoirs for practice in the Member States

## 2.1. Rationale

A survey was done in January 2023 with the aim to better understand the (baseline) situation in each MS regarding a) the current state-of-play of the national/regional knowledge reservoirs for practice included in the CAP Strategic Plans and b) key issues associated with their planning, development and management. This survey provided the baseline information for the development of the first periodic assessment. The survey was distributed in preparation of the Policy Knowledge Platforms event (Online) on 26<sup>th</sup> January 2023 and gathered information on both a) planned and existing knowledge reservoirs for practice included in the CAP Strategic Plans, and b) those that were already under development. The survey also collected information on knowledge reservoirs for practice that already existed but are not specifically mentioned in the CAP Strategic Plan. The survey questions can be found in Annex 1.

In total, 89 valid survey responses from 26 Member States with 27 CAP Strategic Plans including responses from 8 regions within MSs, namely from Belgium, Spain and Italy were collected. Over 75 % of the respondents were from CAP Managing Authorities, AKIS Coordination Bodies, National Rural Networks (NRNs)/CAP network support units or a combination of those (several respondents had multiple functions). Moreover, 80% of the respondents were directly involved in the development and management of KRs for practice, either through AKIS planning and decision making, coordination or implementation of KR development and/or the management of KR content.

# 2.2. Status of the knowledge reservoirs for practice in the Member States

In only six of the 26 MSs, the creation of a KR for practice is stated in section 8 of their CAP Strategic Plan, namely in Belgium-Flanders, Estonia, Hungary, Croatia, Italy and Slovenia. In the CAP Strategic Plans of nine MSs, the creation of a KR is not mentioned, namely in Austria, Belgium-Wallonia, Bulgaria, Cyprus, Germany, Denmark, Latvia, Romania and Sweden. In 12 MSs contradictory responses were provided (Czech Republic, Finland, France, Greece, Ireland, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Slovakia, and Spain). These contradictory responses are likely due to the complex situation of the country linked to the structure and functioning of the regional AKIS or internal differences in what was considered a KR for practice.

In terms of priority of the (further) development of the knowledge reservoir for practice relative to other actions in the AKIS Strategic Approach in each MS, most respondents scored this as a medium to high priority.



## 2.3. Types of existing knowledge reservoirs

Three types of existing knowleege exchange platforms were identified based on the survey results (Fig. 2).

## 2.4. Characteristics of the knowledge reservoirs

Information about the language, anticipated users/target group and content exchange of the KRs that were either planned or already implemented in the MS was collected.

#### Language

The knowledge reservoirs planned and/or implemented in most of the MSs only use one language, their national language (Austria, Czech Republic, Greece, Italy, Latvia, Slovenia). In five MSs, the KR was bilingual with the English language in addition to the national language (Estonia, Lithuania, Netherlands, Portugal, Slovakia) and three MSs have multi-lingual (national or regional languages) KRs (Belgium, Finland, Spain).

#### Anticipated users/target group

All (proposed) KRs targeted farmers and advisors. Further, anticipated users/target group of the knowledge reservoirs for practice varied, including, in decreasing order of relevance, researchers, foresters, teachers/lectures and policy makers. Although supply chain actors were targeted least, they were still identified as a relevant target group.

#### Possibility to exchange content with the EU-FarmBook

For most respondents, it was very difficult to understand if there was a possibility to have an easy content exchange between the MS/regional KRs for practice and the EU-FarmBook. The reasons behind this was that there was not enough clarity on the interoperability between the EU-FarmBook and the existing or planned KRs. However, 22% of the respondents indicated that they could foresee an easy exchange between the national/regional reservoirs and the EU-FarmBook in the future.



## 2.5. Challenges in development of a knowledge reservoirs for practice




Fig. 3: Challenges currently faced or anticipated in the development and management of knowledge reservoirs for practice (n:17 MS).

When asked to identify the challenges currently faced or anticipated in the development and management of the KRs for practice, respondents indicated the development of a user-friendly database and the compatibility issues with other sources of information (e.g. other knowelege reservoirs) as the most important challenges. Furthermore, other frequently reported challenges included attracting end users, intermediaries such as advisors, and ensuring the FAIR<sup>1</sup> data principles (Fig. 3).

Nevertheless, it was possible to identify and summarize the kind of support that would be helpful to develop the MS level KRs for practice further as:

- 1. Knowledge exchange on experiences of the other MS
- 2. Share good practices to develop a KR
- 3. Networking/Engagement with end-users
- 4. Language availability/translation
- 5. IT support
- 6. Enhance KR functionality

# 2.6. Survey concluding remarks

This survey aimed to better understand the situation in each MS regarding a) the current state-of-play of the national/regional knowledge reservoirs for practice included in the CAP Strategic Plans and b) key issues associated with the planning, development and management. The survey results showed that the situation in most MSs is still evolving. The results indicated that there is a great diversity of contexts under which the KRs are or will be developed as well as great diversity in terms of priority given to the KRs as a tool to strengthen the AKIS.

There is also variation in situations, as in some MSs a KR for practice has already been established and is functional while in other MSs a KR has not yet been planned.

Moreover, in some MSs a layer of complexity is added as the KRs might be developed at a regional and not at the MS level.

Even though the survey results revealed that the situation is complex, it is a good starting point to identify opportunities to connect the MS or regional reservoires with the EU-FarmBook. Moreover, based on the findings of this survey a first periodic assessment was developed to further explore the specific situation in each MS.

# 3. First periodic assessment

## 3.1. Rationale and objective of the first periodic assessment

The periodic assessment is a tool designed to support the AMBs in their adaptive planning process to develop 'tailor-made' responses for each MS/sector by the specific characteristics of their national/sectorial AKIS and the progress made with the implementation of their CAP strategic plan (Task 3.1, see also Figure 1). The periodic assessment aims to assess the state-of-play with the embedding of results from EUfunded R&I projects into the national/regional AKISs of the 27 MSs. The assessment has an specific focus on the planning, development, and management of 'knowledge reservoirs for practice' included as part of Section 8 in the CAP Strategic Plans or developed through other initiatives. The outcome of the periodic assessment provides the AMBs with an overview of the situation in their MS/sector and an understanding of how and where the EU-FarmBook can strengthen the knowledge flow in the national /regional/sectorial AKIS. These assessments will be published as assessment policy notes each year and feed into the adaptive planning of WP3 (T3.1) with the purpose of adjusting the activities of the WP in response to the dynamic environment in the MSs and sectors. This first periodic assessment has a MSs focus and the questions targeting the sector AMBs are limited. However, the role of the sector AMBs will have increasing relevance in future assessments.

# 3.2. Periodic assessment methodology




Fig. 4: Theoretical "pathways" within the project for "embedding" the use of the EU-FarmBook platform into the different AKISs

The AMBs will use a pre-defined template to undertake a periodic assessment every 12 months (M9-M69). The periodic assessment form will be updated each period to reflect the evolving context in MS/sector. The template for the first Periodic Assessment can be found in Annex 2. The periodic assessment is structured around the theoretical "pathways" identified in the project for "embedding" the use of the EU-FarmBook platform into the different AKISs (Fig. 4). These pathways were developed during the first Ambassador training workshop in Paris between the 8 and the 10 of March 2023 (see D3.1 – Annex 3). These pathways provide a structure for planning the engagement activities of the AMBs. Further explanation on the AMBs pathways can be found in Deliverable D3.6 Adaptive plan of knowledge networking activities (1).

At this stage of the EU-FarmBook project, the periodic assessment focusses on the state-of-play for "embedding" the use of the EU-FarmBook platform into the different AKISs in relation to Pathways 4,5,6 and supports the identification of KRs related to Pathway 7 and 8 (Fig. 4). The assessment related to Pathway 1 and 2 will be covered at project level through the uploading task T3.4 (see Deliverable D 3.2: Report on progress on promoting and supporting the uploading of knowledge objects (1). The first periodic assessment form is specifically designed for AMBs with a Member State focus. AMBs with a sector focus only need to work on section 3.7 "Pathway 7 & 8 knowledge reservoires (interoperability).

The starting point of the periodic assessment are the AKIS updates for each MS developed by modernAKIS. ModernAKIS (https://modernakis.eu/) is one of the EU-FarmBook's sister projects focusing on the modernisation of Agriculture through more efficient and effective Agricultural Knowledge and Innovation Systems (AKIS). Furthermore, other additional/supplementary information to be consulted are the i2connect project reports that provide an overview of the AKIS with a main focus on advisory services and the Guidelines on Evaluating the AKIS Strategic Approach in the CAP Strategic Plans (https://eu-cap-network.ec.europa.eu/sites/default/files/publications/2023-06/EUCAPNetwork Report EvaluatingtheAKISStrategicApproachinCAPStrategicPlans.pdf).



The assessment builds on the survey conducted in January 2023 (see Chapter 2) and continues to explore the development of KRs for practice in the MSs specifically related to Pathways 7 & 8 knowledge reservoir (inter-operability). In the periodic assessment, information will be collected on both planned and existing platforms, plus those that may already be under development. Additionally, information will be collected related to platforms that already exist but are not specifically mentioned and/or developed as part of the AKIS Strategic Approach, such as platforms developed by R&I projects (H2020/HEU) or sector level, since these are potentially also very useful sources of knowledge and it might be useful to connect them with the EU-FarmBook. Furthermore, the questions in the assessment aim to get an understanding of the key issues associated with the planning, development, and management of these online KRs, to analyze their current and expected by the members of the AKIS at EU/national/regional level and tp pinpoint opportunities to connect existing or new knowledge platforms with the EU-FarmBook and to embed the use of the EU-FarmBook at EU/national/regional AKISs. AMBs are requested to collect this information in a supplementary list to the project Customer Relations Management system (CRM, see details in D3.2: Report on progress on promoting and supporting the uploading of knowledge objects (1), at a central place on the EU-FarmBook SharePoint, to ensure the easy access to this information by the AMBs and other project consortia members.

# 4. Next steps

The AMBs will undertake a periodic assessment every 12 months in alignment with the iterative recurrent activities as part of the AMBs adaptive planning process. The first period assessment will be conducted between M17 (December 2023) and M19 (February 2024) in preparation of the Reflection and Refinement planning workshop from 9-11 April 2024 (M21). During the assessment period, the T3.3 team will provide continuous support to ensure the assessment is completed accurately and on time.

The period to complete the periodic assessment has been extended to M19 in order for the ambassadors to combine their efforts in contacting all the relevant AKIS member in preparation of the pre-launch of the EU-FarmBook platform on 8 February 2024 with the collection of relevant information for the periodic assessment.

Towards the end of M20 the results of the first assessment will be collated and shared in the form of a set of policy notes. These notes will be included in the next deliverable D3.16.




Fig. A1: Theoretical pathways within the project for "embedding" the use of the EU-FarmBook into the EU/national/regional AKISs
